The scholarships offered by the **TD** and Fondation Père Lindsay are intended for students or recently graduated students who cannot afford the pay the program fees.

Depending on how many registrations are received and the quality of the proposed projects, 4 to 7 scholarships will be offered and officially announced in the week of February 6, 2017. The successful candidates will be selected by a committee made up of members of the Fondation Père Lindsay, people active in music and university representatives. The committee's decisions are final and non-negotiable.

To be eligible for a scholarship, you need to:

1. Be a Canadian citizen and have lived in Quebec for at least 3 years
2. Be accepted into the program
3. Be currently enrolled in a university music program or a recent graduate of a university music program (maximum 5 years since graduation)
4. Commit yourself to be present for the entire program from February 25 to March 12, 2017
5. Have limited financial resources to cover the costs of the program
6. Pay the registration fee as well as the difference between the amount of the scholarship and the total tuition fee.
